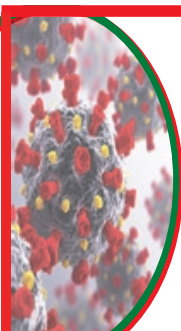

ICAM CLEARED TO ADMINISTER EXAMS



The Presidential Taskforce on COVID -19 cleared ICAM to administer examinations having gone through a rigorous assessment process. Firstly, offices of the Director of Health and Social Services (DHSS) inspected examination centres in Mzuzu, Lilongwe, Zomba and Blantyre and were later followed up by representatives from the Ministry of Health, Education and internal security.

Among the procedures followed during the examinations include handwashing with soap, temperature checks, hand sanitizing, fumigation of examination rooms after every sitting and the availability of health surveillance assistants, nurse and clinician as well as a stand by ambulance at each examination centre.

Expressing his delight on the approval to administer examinations, ICAM CEO attributed the success to the organisation's thought leadership process.

Dr. Gondwe stressed: "We just had to find means of ensuring that students realise their dream. COVID -19 should not hinder professional progress. As a thought leader, ICAM had to take the initiative to contact relevant authorities and comply with all necessary provisions so that examinations are administered accordingly."

ICAM examinations were administered from 25th August up until 3rd September. According to the Director of Education and Training at ICAM Chrissie Jere, results will be released mid - October.
